AN ORDINANCE AMENDING THE 2009 APPROPRIATION ORDINANCE.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATHENS, OHIO:

SECTION I: The 2009 Appropriation Ordinance, 0-130-08, is hereby amended by reducing General Fund 101, by Two Hundred Forty-Three Thousand Dollars (\$243,000.00) and Sewer Fund, 750, by Two Hundred Sixteen Thousand One Hundred Dollars (\$216,100.00) as follows:

General Fund, Mayor, 101.101, T.C. 100, by Twenty Thousand Dollars (\$20,000.00) and T.C. 300 by Twenty-Five Thousand Dollars (\$25,000.00);

General Fund, Auditor, 101.102, T.C. 100, by Fifteen Thousand Dollars (\$15,000.00), T.C. 200, by Five Thousand Dollars (\$5,000.00), and T.C. 300, by Ten Thousand Dollars (\$10,000.00);

General Fund, Law Director, 101.104, T.C. 300, by Five Thousand Dollars (\$5,000.00);

General Fund, City Council, 101.105, T.C. 300, by Ten Thousand Dollars (\$10,000.00);

General Fund, Lands & Buildings, 101.112, T.C. 100, by Thirty-Seven Thousand Dollars (\$37,000.00), T.C. 200, by Twenty-One Thousand Dollars (\$21,000.00), and T.C. 300 by Twenty Thousand Dollars (\$20,000.00);

General Fund, Police, 101.207, T.C. 200, by Five Thousand Dollars (\$5,000.00) and T.C. 300, by Ten Thousand Dollars (\$10,000.00);

General Fund, Fire, 101.208, T.C. 300, by Twenty-Five Thousand Dollars (\$25,000.00);

General Fund, Code Enforcement, 101.351, T.C. 100, by Thirty Thousand Dollars (\$30,000.00);

General Fund, Parking Enforcement, 101.718, T.C. 300, by Five Thousand Dollars (\$5,000.00);

Sewer Fund, Maintenance, 750.635, T.C. 100, by Fifty-One Thousand Eight Hundred Dollars (\$51,800.00), T.C. 200, by Forty-Eight Thousand One Hundred Dollars (\$48,100.00), and T.C. 300, by Thirty-Six Thousand Four Hundred Dollars (\$36,400.00);

Sewer Fund, Administration, 750.636, T.C. 200, by One Thousand One Hundred Dollars (\$1,100.00) and T.C. 300, by Two Thousand Two Hundred Dollars (\$2,200.00);

Sewer Fund, Plant, 750.637, T.C. 100, by Forty-Four Thousand Two Hundred Dollars (\$44,200.00), T.C. 200, by Ten Thousand One Hundred Dollars (\$10,100.00), and T.C. 300, by Twenty-Two Thousand Two Hundred Dollars (\$22,200.00), and reducing the total appropriations by said amounts.

SECTION II: The 2009 Appropriation Ordinance, 0-130-08, is further amended by increasing Sewer Fund, Administration, 750.636, T.C. 100, by Four Thousand Six Hundred Dollars (\$4,600.00), and increasing the total appropriations by said amount.

SECTION III: This Ordinance shall be in effect and full force upon its passage and approval by the Mayor.
